# **5.1 Superintendent/President Updates**

Dr. Endrijonas welcomed all to the second week of the fall semester and introduced Vice President of Student Affairs, Paloma Arnold, to provide an update on increasing fraudulent enrollment activity:

- Admissions & Records, IT, and Financial Aid have been greatly impacted by bots and are spending significant time to mitigate fraudulent enrollment.
- Student Services is working hard to protect financial aid and noted that these bots are not our students but are taking space from real students.
- Members discussed various impacts to students and classes and ideas for further mitigation.

Dr. Endrijonas announced the upcoming Sustainable Blue Economy event in the Campus Center from 4:00-7:00 p.m. on Wednesday, September 4 and also encouraged all to attend the first First Thursday of the fall on September 5 at the Luria Library patio.

Dr. Endrijonas will be holding virtual information sessions with candidates running for the three Board of Trustee seats on the ballot in November. The first session on Thursday September 12 will include an overview of the California Community College system. The second session on October 1 will introduce each Executive Team member and the areas they oversee.

# 5.2 Educational Vision Plan Final Draft - M. Villagomez, P. Arnold, C. Smith

Dr. Maria Villagomez, Vice President of Academic Affairs, noted that the Educational Vision Plan was presented as a discussion item at the last CPC meeting and is provided again for any final feedback. This will be presented formally to the Board of Trustees on September 12.

Carola Smith, Vice President of the School of Extended Learning, reviewed next steps now that the committee is entering an operational level. Each area will form a workgroup to implement the strategies and activities in the plan and will report out regularly to CPC. Kim Monda, Academic Senate Past President, stated an interest in adopting a model that will work well for instructional faculty.

# 5.3 Adopted Budget for Fiscal Year (FY) 2024-25 - B. Fahnestock

Dr. Endrijonas noted that the Board is required to pass a tentative budget in June and a final budget by September 15 each year. Brian Fahnestock, Vice President of Business Services, provided the budget presentation that will go to the Board on September 12 to meet that deadline.

Vice President Fahnestock reviewed state funding uncertainties and overspending that are significant factors in the growing structural deficit. Members asked for insight on where the deficit might be reduced and ideas for where to start. Dr. Endrijonas and Vice President Fahnestock explained that working towards a balanced budget will include conversation and consultation with the College community as a whole and will take time over the coming years. The Board is interested in hearing ideas and will have a study session this fall to review the Budget Sustainability Workgroup recommendations for efficiency.

Dr. Endrijonas gave an overview of the Student Centered Funding Formula and the challenges that are shared across California Community Colleges as well as those that are unique to the Santa Barbara City College District.

Dr. Magenau announced that the first Board Policies and Administrative Procedures (BPAP) Committee will begin meeting on September 20.

# 5.5 Metered Parking Spaces in Lot 1A - B. Fahnestock

Mr. Fahnestock introduced the need for additional short-term parking spaces for students to visit the Campus Store, Cafeteria, Counseling, Cashier's Office and other student services for up to an hour. The plan is to grow the eleven 30-minute spaces to twenty-three 1-hour spaces.
